Ms. No.3, Backward Classes Welfare (C-2) Department, dt.04/04/2006 and G.O.Ms.No.26, BC Welfare (C) Dept., dt.09/12/2013, **P.H. certificate in case of disabled candidates, migration certificates for candidates who migrated from Telangana to Andhra Pradesh etc.**, failing which, they will not be treated as eligible with reference to the particulars furnished by him/her in the Online application form / Certificates.
