In continuation to the Result Notification dt: 20.04.2017 it is hereby informed that, on the basis of the Main Examination (CBT) (Without Screening Test) held on 02/02/2017 FN & AN at 13 districts of Andhra Pradesh and Hyderabad in Telangana State to the post of Assistant Engineers (Environmental) in A.P. PH&ME Department, vide Notification no: 10/2016, Dt: 30.09.2016, the candidates with the following Registered Numbers have been provisionally admitted for verification of Original certificates in addition to the earlier list since their applications were not considered earlier due to incorrect data furnished by the service provider. **The verification of Original Certificates for this candidates is scheduled on dt; 26.05.2017 at 10.30 A.M. at the O/o Andhra Pradesh Public Service Commission, Prathibha Bhavan, M.J. Road, Nampally, Hyderabad-500001.** The verification of original certificates for the remaining candidates will be held as per schedule. Out of the above list, if required candidates do not turn up for verification in any category candidates, no further time would not be granted. The result copy can also be seen in the Commission's Notice Board.

The two candidates provisionally admitted for verification of Original Certificates are required to produce the Original Certificates relating to **Age (SSC), proof of Age Relaxation, Qualifications, Study Certificate (from 4<sup>th</sup> class to 10<sup>th</sup> class), Integrated Community Certificate in case reserved candidates, Certificate of exclusion from Creamy Layer in case of BCs** from revenue authorities in terms of G.O.Ms.No.3, Backward Classes Welfare (C2) Dept., Dt: 04.04.2006 read with G.O.Ms.No.26, BC Welfare (C) Dept., Dt: 09.12.2013, **P.H. (OH) Certificate in case of disabled candidates and Migration certificates for candidates who migrated from Telangana to Andhra Pradesh etc.,** at the time of verification of Certificates, failing which, they will not be treated as eligible with reference to the particulars furnished by him / her in the online application form / Certificates. The results of such candidate (s) shall be cancelled at any stage in the process of selection. The Commission has the right to disqualify any candidate, if he / she is not found eligible for any reason.

The qualified candidates should download the Memo, 2 Checklists, 2 Revised Attestation forms from the Official website of APPSC, website [www.psc.ap.gov.in](http://www.psc.ap.gov.in). The individual Memos will be sent to the candidates. Even in case he / she has not received the Memo he/she can attend certificate verification as per the date mentioned in the verification schedule. Marks lists of all the candidates, who appeared in the Main Examination (CBT) is also available on website.
