A list of 148 candidates provisionally admitted to Certificate Verification for Oral Test for appointment by direct recruitment to the **POSTS INCLUDED IN CCS-I EXAMINATION (GROUP I SERVICES)**, was published in the Commission's website on 12.05.2017 based on the results of the Main written examination conducted by the Commission on 29.07.2016, 30.07.2016 and 31.07.2016.

During the Certificate Verification held on 05.06.2017 to 07.06.2017, 3 candidates have absented themselves and the eligibility status of 1 candidate has changed.

Consequent to that, the candidate with the Register number mentioned in the annexure has been deleted for the reasons given thereof.

In order to adhere to the ratio of 1:2 for admission to Certificate Verification for Oral Test, it has been decided by the Commission to substitute candidates in the place of absentees for Certificate Verification.

Hence, apart from the candidates who had already completed the certificate verification and found eligible, the candidates with the following register numbers are hereby admitted provisionally to the certificate verification for the said post. The certificate verification will be held on **30.06.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. - 1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for next stage of selection.
- 2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification to find out their eligibility for admission to Oral Test based on the marks obtained by them in the Main Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Certificate Verification is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, Differently Abled Status, PSTM etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification will be cancelled and they will not be admitted to next stage of selection.
- 3. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP Nos. 20875/2016, 26205/2016, 26572/2016 and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
- 4. Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to attend the Certificate Verification with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the next stage of selection.
