Eligibility Criteria : 1. He must be a citizen of India.

- 2. Candidates must hold a Bachelor's Degree with at least one of the subjects, namely, Botany, Chemistry, Forestry, Geology, Mathematics, Physics, Statistics and Zoology or a Bachelor's Degree in Agriculture or in Engineering in any University incorporated by an Act of the Parliament or of the State Legislature in India or other educational institutions established by an Act of Parliament or declared to be deemed as Universities under Section 3 of University Grants Commission Act, 1956 (3 of 1956) or a foreign University approved by the Central Government from time to time or posses a qualification which has been recognised by the State Government for the purspose of admission to the examination.
- 3. Candidates must posses a working knowledge of Mizo language upto Middle School Standard
- 4. Subject to the provision of sub-rule (5), Candidates for direct recruitment shall be posses at least the following physical standard for height and chest measurements as follows:-

The following minimum height standard may be allowed in the case of candidates belonging to Scheduled Tribes and to races belonging to Gorkhas, Nepalese, Assamese, Khasis, Ladakese, Sikkimese, Bhutanis, Garhwals, Kumaonis, Nagas, Mizos and candidates belonging to ethical races of Arunachal Pradesh.
