

(4) Age relaxation and weightage on marks will be given to the eligible candidates those who are working in similar assignment under any scheme under H&FW department as per rules stipulated in the above GA dept. notification. (5). Selection will be done strictly on the basis of merit in the qualifying examination as required for the posts and no weightage will be given for higher qualification. (6).
