 - 1. Age limit: Maximum age limit for Part Time Medical Doctor is 65 years as on 31.07.2016.
 - 2. The enagement will be purely temporary, on contractual basis for a period of one year, which can be renewed as per requirement on mutual consent.
 - 3. The selected candidates shall not claim for regular appointment at the Institute/ICAR.
 - 4. No TA/DA will be paid for attending the walk in interview.
 - 5. The applicant must bring with them original document along with one set of photocopy of the same at the time of interview.
 - 6. No objection certificate from the employer, in case of employed elsewhere.
 - 7. Experience certificate in original (If any).
 - 8. Interested candidates may appear for walk in interview on **05.09.2016 at 10.30 A.M.** at IINRG, Namkum, Ranchi with complete bio-data i.e. Name, Address, Mobile No., Educational Qualification, MCI registration No. & Experience etc. with one recent passport size photograph.

Terms & Conditions:-

- 1. That he/she will visit the dispensary of Indian Institute of Natural Resins & Gums for at least 3.00 p.m. to 6.00 p.m. on three alternate/continuous days in a week (atleast 12 visits per month) and he/she will attend the authorized patients (the employees and members of their family)
- That he/she will also attend and administer medical aid to the authorized patients of the institute residing at Ranchi at his/her Clinic/Chamber at Ranchi and any other relevant duty assigned by the Director, IINRG.
- 3. That he/she will get fixed consolidated remuneration of Rs. 13,000/- (Rupees Thirteen thousand) only per month. No dearness allowance or any other type of allowance is admissible over and above consolidated remuneration.
- 4. That he/she will attend any employee of the Institute, if called as a special case outside the routine duty hours as referred above, he/she will be paid fee for this as per Medical Attendance Rule. As regards leaves, he/she will be entitled only casual leaves of 8 days and Restricted Holidays for 2 days in a year.
- 5. Initially, the term of appointment shall be for One year, which can be extended subject to his/her satisfactory services.
- 6. No vehicle or transport allowance will be provided for visiting the Institute.
- 7. That he/she will also carry out ordinary first aid work when necessary in respect of authorized patient.
- 8. That he/she will take necessary preventive measures by obtaining the assistance of Public Health Department or by himself/herself, such as giving vaccination or inoculation to the staff if & when necessary.
- 9. That he/she will look after the efficient and proper running of the Institute Dispensary as regards to medicines, equipments and supervision of the work of the Dispensary staffs is concern.
- 10. The appointment will be purely contractual. In the event of his/her desire to resign or the competent authority not finding his/her services satisfactory, one month notice will be required from either side. He/she will have no claim for continued employment in IINRG/ICAR. However. Director, IINRG reserves the right to terminate the appointment without assigning any reason.
- 11. That he/she will produce original certificates as regards to qualification, experiences, no objection (if employed).
- 12. The candidate must be free from any legal proceeding/vigilance case.
- 13. That if the declaration or information furnished by him proves to be false or found to have willfully suppressed, he/she will be liable for removal from services immediately and other such action as may be deemed necessary.
