The appointment will be on contract basis for one year and co-terminus with the project.

Qualification and Experience:

SRF: Masters in Chemical Engineering / Biochemical Engineering / Biotechnology and allied disciplines with two years of relevant research experience in the hydrodynamic cavitations and /or sonication will be preferred.

RA: Ph.D. degree or 3 years post experience with ME / MTech. in Chemical Engineering / Biotechnology / Biochemical Engineering / Environmental Engineering / Related Field. Candidates who have submitted their Ph.D. Degree but are yet to be awarded can also apply. Candidates having hands-on experience in handling microbial techniques and processes or large scale cultivation of microalgae for biofuel production and / or candidates having hands on experience in processes optimization and life cycle analysis will be preferred.
