i) **Minimum Qualifications :**

a) Bachelor's degree in Engineering in the relevant branch with **First Class** or equivalent

If the candidate has a Master's degree in Engineering, first class or equivalent is required at Bachelors or Masters level

ii) **Age limit :** A candidate must have attained the age of 21 yrs and must not have attained the age of 35 yrs on the last date fixed for submission of application. The upper age limit is relaxable by 5 yrs in case of candidates belonging to SC/ST and OBC as laid down by the Government.
