Candidates are invited for a **Walk-in-Interview** for following positions on contractual basis under the project entitled "Targeted Intervention to Expand and Strengthen TB Control in Tribal Populations under the Revised National Tuberculosis Control Programme, India" on **30th September 2016 at 2.00 p.m. at District TB Clinic, Jaipur-II, Jaipuriya Hospital Campus, Milap Nagar, Tonk Road, Jaipur.**

The place of posting will be in Banswara, Dungarpur and Pratapgarh Districts of Rajasthan. Only those who are willing to serve in these districts should appear for the interviews.

1. Position - Field Supervisors

- a. Total Positions - 7. (UR - 5; OBC - 1; SC/ST - 1)
- b. Essential Qualification - Graduate in Life Sciences from a recognized University.
- c. Consolidated Remuneration - Rs. 20,000 per month

2. Position - X-Ray Technologist

- a. Total Positions - 3. (UR - 2; ISC/ST - 1)
- b. Essential Qualification - 10+2 or equivalent examination passed with science subjects from a recognized board; and Radiographer's/X-ray technologist's course of minimum one year duration (including in-field training in diagnostic radiology) passed from a recognized institution..
- c. Consolidated Remuneration - Rs. 16,560 per month

Those who have appeared earlier for the interviews are not required to appear again.

Terms: All the positions are purely temporary. Appointment will be initially made for a period of six months/one year and may be extended further based on the performance of the candidate and the need of the project.
