The job requires:

- Developing appropriate general and commodity specific strategies for efficient marketing of agricultural produce.
- Increasing farmers' access to agricultural commodity markets for better price discovery mechanism / enhancing awareness among farmers regarding physical markets / e-marketing of agricultural produce / quality and grade standard awareness amongst farmers'.
- Organizing FPOs / CIGs for marketing of agricultural commodities.
- Promote market led extension, backward and forward linkages in marketing agricultural produce.
- Preparing convergence plan for trading of agricultural produce.
- Carrying out market / commodity specific analysis to bring improvement in marketing.
- Strengthening contract farming / establishment of private markets / promoting e-trading of agricultural produce.
- Leadership qualities and ability in HR Management to function as executive head of an independent establishment.

Eligibility Conditions:

Educational Qualifications

- Full-time two years MBA / Agri Marketing Professionals from Institute of repute.
The candidates must have passed an examination equivalent to ME standard with Odia as one of the subjects and be able to speak, read & write Odia.
