3. Not a single column should be left unfilled. Instead NIL/ Not Applicable should be mentioned.
4. If the space provided in application form is insufficient, increase the rows/column of the respective item. In all cases, the information sought be provided in the table provided.
5. Applicant shall submit the application in person or by post in the prescribed form together with all enclosures in envelope superscribed **“Application for the post of “ ” in the P.G. Department of “ ” so as to reach the Registrar, Sardar Patel University, Vallabh Vidyanagar- 388120** on or **before 30/05/2017**, Application received after the due date will be liable to be disregarded. The University will not be responsible for postal delay, if any.
6. Applicants who are in service should apply through their present employers. Direct application will not be considered. However such a candidate can send in advance, one copy of dully filled in application form without any enclosure. so as to reach before the deadline. Such an application will be deemed in time, provided the application through proper channel is received within one week after last date. Persons employed after making application in response to this advertisement should bring **“NO OBJECTION”** certificate at the time of interview from their employers.
7. S.E.B.C. candidate should furnish the **Current financial year's "Non-Creamy-layer certificate"** of their parents in the prescribed Performa along with his/her application form, failing which the candidate will not be entitled to get the benefit of reserved category. **(B) Associate Professor**

**(C) Assistant Professor**

- A (i) Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- (iii) Notwithstanding anything contained in sub-clauses (i) and (ii) above candidates, who are, or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.

**Further, the award of degrees to candidates registered for the M.Phil/Ph.D programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ By laws/ Regulations of the Institution awarding the degrees and the Ph.D candidates shall be exempted from the requirement of the minimum eligibility condition of "NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities / Colleges / Institutions subject to the fulfillment of the following conditions: -**

  - (e) Open Ph.D. viva-voce of the candidate had been conducted.
- (a) to (e) as above are to be certified by the Vice-Chancellor/ Pro-Vice-Chancellor/ Dean (Academic Affairs)/Dean (University Instructions)”
- (iv) NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.

- 2. A minimum of ten years experience of teaching industry / research / profession, out of which five years must be at the level of Assistant Professor or equivalent excluding the period spent for obtaining research degree.
