**Note:** Candidates possessing Sports qualifications for the posts of Grade Pay 1900/2000 may also apply for the posts of Grade Pay 2400/2800. If none of the applicants for Grade Pay 2400/2800 qualify for Grade Pay 2400/2800, the same may be considered for recruitment in Grade Pay 1900/2000 against the posts of Grade Pay 2400/2800.

**(2) SPORTS NORMS FOR RECRUITMENT :**

2.3 In Athletics, medal winning performance in National Inter State Senior Athletics Championship may also be considered for recruitment against the posts having grade pay Rs.1900/2000 in pay band Rs-5200-20200.

2.4 (i) In Cricket at International level, representation of main Indian Seniors Team in a Test Match or in a Limited Overs One Day International Match or in a Twenty-20 Overs match shall also be considered for recruitment against the posts having Grade Pay 1900/2000 in Pay Band 5200-20200.

(ii) In Cricket at National level following sports achievements in 4 days/One Day limited overs/Twenty-20 overs Cricket Championships ( except Vizzy Trophy) organized under the aegis of BCCI may also be considered for recruitment against the post having Grade Pay Rs. 1900 in Pay band 5200-20200:-

**Note:** (a) All the recruitment shall be at the minimum of the Scale of pay.

(b) All the Championships mentioned above should have been conducted under the aegis of recognized International/National/State Sports Federation and also recognized by RSPB.

2.6 In **Hockey**, for recruitment against the posts having Grade Pay 1900 or 2000 in PB 5200-20200 at least 2<sup>nd</sup> position in the International Tournaments of four or more Nations may also be considered.

**(3) MINIMUM EDUCATIONAL QUALIFICATION:** (A) For the posts having GP-1900/2000 : - Pass in 10+2 or its equivalent. (b) For the post having GP-2400(Technical) :- Pass 10+2 in Science i.e. Maths or Physics or equivalent. (c) For the post having GP 2800/- :- A university Degree or its equivalent.

(4) **AGE:** 18-25 years as on 01.01.2018. No age relaxation is permissible.

(5) **PERIOD OF RECKONING SPORTS ACHIEVEMENTS:-** The sports achievements of current & previous two financial years will be taken into account for eligibility. Therefore, the sports achievements of 01.04.2015 or after will only be considered.

(6) **HOW TO APPLY:-** (i) Candidate should carefully read all the instructions given in the Employment Notice before filling the Application Form. (ii) Application shall be submitted on good quality white plain A-4 sized paper in the format given in Annexure-A hereunder using only one side of the paper. (iii) The application should be filled either in English or in Hindi. (iv) The application form should be filled by the applicant in his/her own hand writing using a blue/black ball point pen, (v) Serving Government Employees should send their application through proper channel duly forwarded by their controlling officers. The last date will not be extended on account of delay in transmission of the application by the concerned office. However an advance copy of the application may also be submitted. (vi) Candidates claiming refund of Examination Fee must submit self attested copies of the requisite certificates, issued by the appropriate authority.

(7) **WHOM TO APPLY:** Application in the prescribed format, complete in all respect along with all the enclosures should be sent by **ORDINARY POST** only to Chairman, Railway Recruitment Cell N.E. Railway, CCM Annexe Building Railway Road No. 14, Gorakhpur (UP) 273012 or may be dropped in the box kept at the premises of Railway Recruitment Cell, Gorakhpur between 09.30 hrs. to 18.00 hrs. on any working day on or before the last date of application in an envelope duly super scribing "**SPORTS QUOTA 2017-18**".

(8) **EXAMINATION FEE:** (i) For all candidates except those mentioned in sub para (ii) below : Rs. 500/- (Rupees Five Hundred only).

(ii) For candidates belonging to SC/ST/Ex.-Servicemen/Persons With Disabilities (PwDs), Women, Minorities and Economically Backward Classes : Rs. 250/- (Rupees Two Hundred Fifty only), which will be refunded to those candidates who actually appear in the Trial. Fee will be in the form of Indian Postal Order (IPO), drawn in favour of Chairman, Railway Recruitment Cell, N.E. Railway, Payable at Gorakhpur. IPOs issued before the date of issue of this Employment Notice will not be accepted and the Application Form will be rejected. Application received with fee in the form of Demand Draft/Cash/Cheque/Central Recruitment Fee Stamps and Money Orders will not be accepted and application form will be REJECTED. Candidates must write their name and full address at the space provided in the postal order. Save as Stated above, the examination fee is not refundable/transferable/adjustable under any circumstances.

(9) **RECRUITMENT PROCESS :** The recruitment will be based on performance in trial and evaluation of sports and educational achievements.

(10) **GENERAL CONDITIONS OF RECRUITMENT:** (i) Before applying, the candidate should ensure that he/she fulfils all the eligibility norms (ii) The specific position played in the particular game/event if applicable must be mentioned in the application form. (iii) The education or Sports qualifications acquired after the date of application shall not be considered. (iv) Candidates furnishing false information/suppressing the facts will be disqualified and shall be liable for debarment and legal action. Candidates who attempt fraud/impersonation are liable for debarment to appear in the future examinations conducted for recruitment in Railways. (v) Candidate(s) found eligible for appointment have to pass the prescribed medical examination conducted by the railway administration before appointment. (vi) Mere selection of candidates and recommendation for their appointment shall not confer any right on the candidates for their appointment in Railway. (vii) Second Class free journey pass from the nearest Railway Station mentioned in the application form will be issued to the candidates belonging to SC & ST

communities whenever they are called at any stage of recruitment. (viii) The person appointed against Sports Quota in the category of clerks will be required to possess proficiency in typing within a period of four years from the date of appointment. If the candidate does not acquire prescribed typing qualification within the stipulated period, increments due after four years and thereafter shall not be released. (ix) Candidates belonging to Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Jammu & Kashmir, Lahoul and Spiti districts of Pangi Sub-Division of Chamba District of Himachal Pradesh, Andaman & Nicobar and Lakshwadeep Islands should enclose a domicile certificate or a certificate of having passed the qualifying examination from the school/college situated therein. (x) Candidates should be in readiness to appear in the trials at short notice.

**(11) LIST OF ENCLOSURES:** (i) Indian Postal Order for Rs. 500/- or Rs. 250/- (as the case may be). SC/ST, Ex-Servicemen, Persons With Disabilities, Minority candidates and candidates belonging to Economically Backward Classes should enclose their self attested copies of Community certificates issued by appropriate authority. (ii) Self attested copies of educational/technical certificates. (iii) Self attested copy of Sports certificates issued by authorized signatories for events. (iv) For OBC candidates the caste certificate must be on the prescribed format for employment under Govt. of India. (v) Self attested copy of 10<sup>th</sup> class or equivalent certificate as proof of Date of Birth. (vi) Income Certificate in case of Economically Backward Class candidates.

**(13) INVALID APPLICATIONS:** Applications not in the prescribed format, not completely filled/submitted in contravention of the above mentioned instructions will be summarily rejected. Apart from the above, following are the main grounds for rejection of application form: (i) Application forms received through Registered Post/Speed Post/Courier. (ii) Application not on the given format (iii) Incomplete/illegible application forms. (iv) Applications without prescribed Examination Fee (v) Necessary Certificates not enclosed for relaxation in Examination Fee. (vi) Examination Fee being in any other form except Indian Postal Order (vii) Certificates of Educational Qualification and Sports Achievements not enclosed (viii) Two personal identification marks not mentioned in the application form (ix) Declaration not written on the application form (xi) Signature in capital letters (xii) Not affixing self attested photograph on the application form (xiii) Not making all the entries in the application form (xiv) Canvassing, pressurizing or trying to influence in any manner regarding recruitment/candidature.
